	Gas Leak	<p>Employees, Volunteers Players and visitors Contractors Children</p> <p>Injury from fire or explosion.</p>	<p>Any gas hot water heating systems are inspected annually by a competent person (e.g. Gas Safe registered engineer) and record kept available.</p> <p>Employees and volunteers are aware of gas leak procedure.</p> <p>Smoking inside the building is prohibited and suitable signs displayed.</p> <p>The gas isolation valve is readily identifiable and accessible.</p>	Low	Low			
	Electricity	<p>Employees, Volunteers Players and visitors Contractors Children</p> <p>Injury from electric shock, burns.</p>	<p>Fixed electrical installation correctly installed by qualified electrician and inspected regularly. All repairs by qualified electrician. Players are warned not to take electrical items into shower/wet areas. All electrical circuits in the changing areas are protected by residual current devices.</p>	Low	Low			
	Fire	<p>Employees, Volunteers Players and visitors Contractors Children</p> <p>Fatality, burns inhalation of smoke.</p>	<p>The plant room is fitted with a smoke detector.</p> <p>The plant room is secured and not used to store combustibles.</p> <p>A specific fire risk assessment has been carried out.
